TOUR OF BRITAIN CYCLE EVENTS

TEMPORARY RESTRICTION OF TRAFFIC MOVEMENT ORDER

1. ORDER i) temporarily restricting the use by vehicles of those lengths of roads as set out in Article 2 and ii) temporarily suspending the one way restriction on the U60765 Dickens Avenue in the BOROUGH OF GREAT YARMOUTH
2. Save as provided in Article 5 of this Order and whereas the Norfolk County Council as Traffic Authority for the Administrative County of Norfolk is satisfied that the staging of the Tour of Britain Cycle Event is required to take place from the C544 Tuesday Market Place in the TOWN OF KING'S LYNN to the C607 South Beach Parade in the BOROUGH OF GREAT YARMOUTH the effect of which will be to temporarily restrict passage:
  - a) along the route as set out in the SCHEDULE to this Order
  - b) at those points joining the route in the SCHEDULE to this Order
  - c) only whilst the Tour is in the vicinity of those pointsand that in consequence the suspension of the one way restriction on the U60765 Dickens Avenue (hereinafter referred to as the said road a)) will be imposed in the BOROUGH OF GREAT YARMOUTH:
3. In consequence, traffic over the route and at points joining the route, except for any vehicle participating in the Tour, should be restricted from 15 September 2010 for the duration of the Tour
4. The Order affects such roads as are in the County of Norfolk
5. Nothing in this Order shall apply:
  - a) to anything done with the permission or at the direction of a police constable in uniform
  - b) to any vehicle being used for police, fire brigade or ambulance purposes, or the purposes of a statutory undertaker in an emergency which necessitates the bringing of vehicles into a section of road to which this Order applies
6. Insofar as any provisions of this Order conflicts with any provisions of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provisions of this Order shall prevail

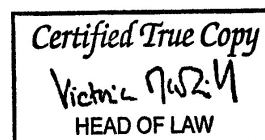

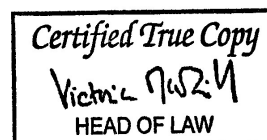
